

## After your mediation or disagreement resolution meeting - frequently asked questions

### **What if I'm not satisfied with the outcome of mediation?**

Contact your local Independent Advice and Support Service (IASS), formerly known as Parent Partnership, who will explain how to appeal to the first tier special educational needs and disability tribunal.

Contact the special educational needs team at your local authority if you need further support. Your local IASS service and Independent Parental Special Education Advice (IPSEA) will also be able to help you.
