

Terms and Conditions

General Information

1. The raffle opens on Monday 27th January 2025.
2. The closing date for entries is Monday 5th May 2025 at 23:59. Any entries received after this date will not be eligible.
3. Tickets are priced at £30 each. However, donations of £30 and over will be accepted and all donations are used for sponsorship of Join Together Festival.
4. There is no limit to the number of tickets an individual or business can purchase.
5. Entry is open to all small businesses operating in the UK.

How to Enter

6. To enter, make the raffle payment [HERE](#).
7. Upon receipt of payment, the Together Trust fundraising team will contact you within three working days to provide your raffle number(s).
8. Entrants must be aged 18 or over and must operate a small business. For the purpose of this sponsorship raffle, a small business is defined as a business that meets the following criteria:
 - Has fewer than 15 employees.
 - Is independently owned and operated, and not part of a larger parent company or group.
9. No cash alternative will be offered for the prize.

Judging and Winner Selection

10. The raffle draw will be conducted using a random number generator by two Together Trust employees.
11. The result of the draw is final and binding and no discussion will be entered into regarding entries or results.
12. The draw will take place no later than Wednesday 7th May, and the winner will be notified by email.

The Prize

13. The prize is the Bronze Sponsorship Package for the Join Together Festival on Saturday, 5th July 2025, valued at £2,000. This package includes:
 - Preferred exhibition stand placement at the event.
